

## STARTUP VIRTUAL

TERMS AND CONDITIONS





#### **CONCEPT**

The Go-ON Incubator (NONAGON - Science and Technology Park of S. Miguel) aims to facilitate, through a set of support services (directly or through established partnerships), the sustained development of startups business ideas.

It has also the purpose of promoting the interaction between the business environment and educational and research and development institutions, as well as the contact with investors (Venture Capital, Seed Capital and Business Angels, or other forms of funding), in order to benefit from the advantages, synergies and complementarities that result from it.

The NONAGON Association finds relevant to provide the virtual incubation services henceforth referred to as just Virtual STARTUP Virtual, extending its offer to entrepreneurs who, whether being or not physically located/installed in the regional market, virtually, with a reduced costs' structure.

Scope

#### **ARTICLE 2**

Target Public and Admission Requirements

The present Terms and Conditions aim to define all the operating procedures of STARTUP Virtual, from the application, selection and incubation processes, through the identification and characterization of the location of the Incubator's facilities and obligations of both parties.

Candidates to STARTUP Virtual can be self-employed entrepreneurs and legal persons, provided that the beginning of the activity does not exceed 3 years from the date of the expression of interest and that are in the process of sustained development of their business ideas in the following areas:

- a) Research and development or technological innovation;
- b) Scientific and technological considered priorities in the context of Nonagon, such as Information and Communication Technologies, as well as scientific and technological areas considered complementary, namely Aeronautics, Agribusiness, Environment, Electronics, Biotechnology and Health Sciences, Communication and Media, Sea Economy, Energy Efficiency, Creative Industries, and Tourism;
- c) Technology and science based support to the business community;
- d) Human Resources Training in the fields mentioned on item b);
- e) Promotion and diffusion of science, technology and innovation;



### Incubation Process

#### **ARTICLE 4**

### NONAGON's Obligations

- f) Other activities considered to be of direct support, properly justified, to the areas described in the previous paragraphs.
- 1. STARTUP Virtual takes place within a maximum period of 42 months from the grant date, in three distinct and complementary moments:
  - a) Incubation (18 months) for the technological design of the product and/or service;
  - b) Business development (24 months), aimed at gaining scale and internationalization;
  - c) Candidates who have not formed a company or opened activity as an self-employed entrepreneur can also benefit, free of charge, from support for a period up to 6 months, in the customer's discovery and validation process - pre-incubation.
- 1. NONAGON is responsible for providing the STARTUP Virtual beneficiaries the following services:
  - a) General services:
    - i. Use of the Science and Technology Park of S. Miguel address for the purposes of its registered office and postal address;
    - ii. Mail reception;
    - iii. Phone service and message registration and reporting;
    - iv. Use of common areas, such as "take a break" areas;
  - b) Access to physical spaces;
    - i. Use of the Cowork Space, in a hot desking regime, (subject to availability);
    - ii. Access to meeting rooms, subject to availability and by appointment, according to the applicable Terms and Conditions.
  - c) Advanced Services:
    - i. Access to events, seminars, workshops, conferences and short training courses;
    - ii. Access to a specialized mentoring network;
    - iii. Promotion of contact with investors and Park entities;
    - iv. Access to the already implemented networks.
- 2. Specialized technical services are excluded from support services, namely business plans and economic viability studies formulation necessary to



- the preparation and instruction of applications for incentives, market studies and economic advice.
- 3. Regarding the access to physical spaces, the possibility to permanently benefit from an incubation space is excluded, for any other specific needs than those identified in paragraph b) of this article.
- 4. NONAGON also commits to preserve and protect all confidential information provided by the entrepreneurs within the scope of the project to be developed.

### Beneficiary's Obligations

The beneficiary of STARTUP Virtual will perform his/her activity in NONAGON according to the conditions inherent to the characteristics associated with the Science and Technology dynamics, obliging him/herself, namely, to:

- a) Fully comply with the obligations agreed in the contract and from these terms and conditions, including future amendments;
- b) Employ the best efforts to develop the applicant project;
- c) Be available to actively participate in the events organized by the Incubator, namely training events, gatherings with investors and other Park entities and the dissemination of its own incubator;
- d) Pay monthly and promptly the remuneration due to each month;
- e) Provide, by the end of june of each year, the Report and Accounts of the previous financial year;
- f) Provide all the information requested by NONAGON for the exclusive purposes of assessing the progress of the project and aggregate statistical treatment.

## ARTICLE 6 Application

- 1. The application is submitted electronically, by filling the appropriate form, which will be made available after sending an expression of interest to incubadora@nonagon.pt, indicating the phase to which it is applying (preincubation or incubation).
- 2. The pre-incubation phase, by its nature, dismisses the submission of application documents, other than the expression of interest.
- 3. The application for the incubation phase includes:
  - a) Electronic application form properly fulfilled;
  - b) Commercial permanent registered certificate, if the candidate is a legal person;



- c) Beginning of Activity Declaration, if the candidate is a self-employed entrepreneur;
- d) Curricula of the candidate(s) and technical team to be assigned to the project, providing a detailed description of the business activity, of the main accomplished projects and projects in progress and with reference to the amount of time dedicated/allocated by each team member;
- e) Business plan or, in its absence, complete Business Model Canvas;
- f) Criminal record of the members of the corporate bodies of the administration, board or management of the formed company;
- g) Certificate of non-debt to the PT Tax Authority and Social Security.

### 1. In the pre-selection phase of applications for the incubation phase, the following assumptions will be verified:

- a) Compliance with the provisions of the Public Procurement Code;
- b) Adequacy of the activity to be developed with the key activities stated in article 2;
- c) Delivery of other application elements, according to article 6.
- 2. After the pre-selection phase, applications for the incubation phase will be analysed based on several factors, according to Annex I, and evaluated by the analysis committee appointed for this purpose by the Board of Administrators, whose result is expressed on a scale of 0 (zero) to 200 (two hundred).
- 3. If the applicant does not provide, on the application form for the incubation phase, enough information regarding one or more factors, he will be assessed with the minimum score on this(these) factor(s).

# ARTICLE 7 Selection Criteria



- 1. In the pre-selection phase to the incubation phase, self-employed entrepreneurs or legal persons will be excluded if they, as applicable:
  - a) Perform productive activities using polluting technologies;
  - b) Are in insolvency proceedings;
  - c) Have been convicted of an offence concerning their professional conduct and honour by a judgment which has the force of res judicata, for participation in the activity of a criminal organization, corruption, fraud or money laundering in the case of individuals, or, in the case of legal persons, the members of its governing bodies of the administration, board or management have been convicted for those crimes and are in effective functions;
  - d) Do not have a regularized situation towards the tax administration and social security in Portugal;
  - e) Do not fit within the areas defined in article 2;
  - f) Have not delivered the documentation required in article 6.
- 2. In the analysis and evaluation phase to the incubation phase, from all the criteria defined in the previous article, applications that do not meet at least one of the following criteria are excluded:
  - a) 1 human resource 100% dedicated/allocated to the project;
  - b) Present a project not considered innovative, in accordance with the OECD Oslo Manual (4th edition);
  - c) Obtain an application with score below 100 points.

# Contract Notification & Celebration

The decision of attributing the right to use STARTUP Virtual services is notified to the applicant within a maximum period of 30 days from the application submission. Then, the candidate will have a period of 10 working days, under penalty of the application expiration, to:

- a) Proceed with the delivery of additional documents and clarifications requested by NONAGON, if applicable;
- b) Conclude the STARTUP Virtual contract.



### Remuneration & Payment

- 1. The STARTUP Virtual services are made available under annual Service Usage contracts, upon payment of 15 euros per month, plus VAT at the legal rate in force, except for the virtual pre-incubation which is free.
- 2. The amount referred to in the previous number is billed on the first business day of the month to which it relates and must be paid within 8 (eight) days from the invoice receipt, by bank transfer to the account titled by NONAGON, whose IBAN is PT50.0033.0000.45419423270.05.
- 3. Failure to pay monthly remuneration within the period established in the preceding paragraph gives NONAGON the right to charge interest due to late payment, which shall be debited.

#### **ARTICLE 11**

# Contract Resolution & Termination

- 1. All obligations and usufruct of the services provided by NONAGON will be considered automatically terminated when one or more of the following conditions are verified:
  - a) Non-compliance with these Terms and Conditions;
  - b) Failure to pay, as per article 10;
- c) Repeated and unjustified absence from events organized by the incubator;
- d) Evidence of absence or limited effort in the development of the candidate project;
  - e) By initiative of the contracting party, properly justified.
- 2. For the purposes of paragraph 1, NONAGON shall communicate by registered letter with acknowledgment of receipt or by any other means deemed appropriate, the termination of contracts and services provided, taking effect from the date of signature of such notice or communication.

## ARTICLE 12 Publicity

For advertising purposes, promotion and dissemination of activities related to the STARTUP Virtual, NONAGON can use the brand or company name of the client, abdicating the last of any compensation for its use.

## ARTICLE 13 Location

For the purposes of using the registered office, the following is considered: São Miguel Science and Technology Park, Rua da Tecnologia K - Épsilon, n°2, 9560-421 parish of Rosário, municipality of Lagoa, island of São Miguel, Azores.



- 1. NONAGON shall not be responsible under any circumstances for the activity carried out by the contractors and users of the STARTUP Virtual services, and it is only responsible for ensuring that the conditions set out in this regulation are assured for the development of its activities.
- 2. NONAGON shall not be liable in civil or legal cases, in any case, for non-compliance with the fiscal, labour, social security, social and commercial obligations, which are the responsibility of the contractors and users of the STARTUP Virtual services vis-à-vis their suppliers, employees and any third parties.
- 3. The activities performed by contractors and users of STARTUP Virtual services, must be under the law and develop within the law.
- 4. The cases omitted in these Terms and Conditions and doubts in their interpretation should be directed to the administration of NONAGON.
- 5. This regulation is subject to periodic reviews.
